 - a. **2026-APC-01 Greenbelt Homes Rezone.** Rezoning of approximately 19.16 acres from AG Agriculture to FI Flex Industrial. The property is located north of the intersection of Northside Drive and E. County Rd. 850 N.

- b. **2026-APC-02 Future Land Use map updates.** Discuss and review updates. Planning area has been adjusted to include newly annexed land north of I-74. This includes land planned for various mixed use and industrial land uses. Approved updates would be written into the comprehensive plan based on draft map.
- c. **2026-APC-03 Update to Landscape Standards.** Discussion of draft modification language to landscape buffer to accommodate newly annexed northern areas of the Town to mitigate potential impacts of industrial areas adjacent to agriculture and residential uses. Buffer meant for the highest level of screening between most intense uses and incompatible districts now required between all industrial zones and agriculture zones. Option two for the buffer now allows for berms as separators with required maintenance and dimensions based on the height of a structure. If agreeable, staff can put on February's regular meeting agenda as an UDO Amendment.
- d. **2026-APC-04 Update to Administrative Subdivision Amendment.** Discussion of draft modification language. Section number was changed to 9.14. Prerequisites changed require eligible applicants to have a notarized affidavit consent form. Signed copies of the Letter of Compliance are to be kept at

Town Hall and with the Hendricks County Recorder's Office. If agreeable, staff can put on February's regular meeting agenda as an UDO Amendment.
