

**PETITION FOR AND CONSENT TO VOLUNTARY
ANNEXATION INTO THE TOWN OF PITTSBORO, INDIANA**

WHEREAS, _____ (hereinafter, the "Petitioner"), is the owner(s) of property located in Hendricks County, Indiana which is more particularly described and depicted in Exhibit A (the "Real Estate");

WHEREAS, the Town of Pittsboro, Indiana (the "Town") is a municipal corporation whose territorial boundaries are established by ordinances adopted by the Town Council of the Town (the "Council") from time to time;

WHEREAS, Indiana law permits the expansion of the Town's boundaries through a super-voluntary annexation proceeding under Indiana Code § 36-4-3-5.1 (the "Act"), which proceeding is initiated by the filing of a petition signed by all owners of the land to be annexed expressing their desire and consent to be annexed;

WHEREAS, the Petitioner is the sole owner of the Real Estate and desires that the Real Estate be annexed by the Town, and is filing this petition in accordance with the requirements of the Act; and

WHEREAS, the Petitioner otherwise consents to the annexation of the Real Estate by the Town.

NOW THEREFORE, the Petitioner, in support of this Petition for and Consent to Annexation, hereby states the following:

1. The Petitioner is the legal owner(s) of one hundred percent (100%) of the Real Estate.
2. The Real Estate is contiguous to the existing boundaries of the Town.
