PUBLIC HEARING

President John Hart opened the Public Hearing by introducing Murray Clark from Faegre Baker Daniels representing Steel Dynamics, Inc. presented the attached request for Right of Way Vacation a portion of Progress Drive, approximately 514 feet in length, west of Jeff Gordon Blvd. The right of way directly abuts property owned by SDI. Jason reached out to E & B Paving for a change order, additional costs would be \$61,000 to be completed by July 31 with no penalty with the micro surfacing company. Jason would like the Council's permission to spend the extra \$61,000 to fix Brixton the

right way. Bill Majeske made the motion to spend the extra money, Kimberly Carmean seconded. All ayes, motion carries. Striping the roads will follow. John Hart read a thank you note at this time from Jim & Julie Mardis for paving the streets.

Water – Jefferson Park has had its fourth (4th) water leak so the paving of its streets is on hold. John Hart thanked Jason and his crew for handling the Citizens Water main break.
