- · Rec events in the park-
  - The Park was able to partner with the Pittsboro Police Department for Fall Family Fun Night. We had an estimated 500 people visit the park that night and the event seemed to be a great success.
- Christmas Planning
  - Currently planning three events on 11/30-12/2.
    - Friday- Lighting of the Park Christmas Tree and caroling featuring the PUMC choir.
    - Saturday- Christmas Village Fair from 10 am to 2 pm. We would like to host the fair in the parking lot between Dollar General and the shops with Big Tucks on the end. We are currently recruiting vendors and already have approximately 9-10 as well as Big Tuck and the Bank partnering together to provide family portraits and selling Christmas wreaths.
    - Sunday- meet and greet with Santa from 2 pm to 5 pm in the Scout Building in the Park. Currently looking for a Santa and Mrs. Claus for the event.
  - On November 10<sup>th</sup>, the Kiwanis Chapter of North West Hendricks County was able to provide volunteers to assist in putting up Christmas decorations. Currently working on putting the final touches around the park.
- Wood Cutting Fundraiser
  - The Park Board has currently tabled the wood cutting fundraiser and is currently in the process of assessing how much viable wood was received from cutting down the various trees.
- Budget
  - The Park Board has already exhausted its budget for the year. This is due to the unexpected jump in attorney fees from 1-2% each year to about 25% of our budget for 2018.
