1) President Jarod Baker introduced Dee Walters from AccuPay. Dee passed out pens and brochures to the Council. She then went over all the services provided by AccuPay. They are working with Keystone to create a check detail file and a finance file through KeyFund to be able to import payroll into our system. They also offer HR services. Resolution: 318 E Main Street/Explore Possibility of Property and Appoint Purchasing Agent – President Jarod Baker explained the reason for this resolution and went over the details. Jarod Baker made a motion to approve Resolution 2024-07 to Acquire the Real Property and Appointment of a Purchasing Agent, Terry Northern seconded the motion. All ayes, motion passes 5-0.

Fleece Performance: Agreement on Interim Cost of Issuance Payment – President Jarod Baker turned to Jason Love and asked him to explain. Jason explained that Fleece Performance has reached out to us and since so much time has elapsed and the building has changed, the cost of construction is bigger and more costly, they would like to start the process over. Jarod feels we can wait it out and discuss it at a later date. Terry Northern agrees.

Voluntary Annexation: Accept Landowner Petition – Dayton Logistics – Steve Maple reported that the formal acknowledgement has been received and explained that the Public Hearing will be held on April 16th and a vote will be done on May 7th for an effective date of June 7th.
